ITEM ND. 1: CALL TO ORDER	Vice Chairman Brink called the meeting to order at 7:00 pm opening with the Pledge of Allegiance.
ITEM ND. 2: APPROVAL OF MINUTES	MOTION was made by Ed Nikles, seconded by Dennis Brink, and unanimously carried to approve the August 6, 2019 Regular Meeting Minutes and the August 6, 2019 Public Hearing Minutes as presented.
ITEM ND. 3: OLD BUSINESS A) Sunrise Lake Section 9	The submission of a complete Sewage Planning Module was due prior to this meeting: nothing was received. Chris Wood stated that he received a call from the consultant this afternoon with questions regarding the narrative. He was told that they are waiting for the map from Schoenagel and they set up a meeting for next week to go over the Module.
ITEM ND. 3(B): Preserve at Milford Hills	No response has been received from the letter Solicitor Klemeyer sent August 8th asking if the parent company of Milford Realty Building Associates would guarantee the bond.
ITEM ND. 3(C): Other Old Business	There was no Other Old Business at this time.
ITEM ND. 4: NEW BUSINESS A) Other New Business	Karen Kleist informed the Board that in addition to McGoey, Hauser & Edsall doing the subdivision plans for their employee's property on Old Owego, they would like to also do the Sewage Planning Module. The Board had no objection.

MOTION was made by Dennis Brink, seconded by Ed Nikles, and unanimously carried to approve the exoneration of 2019 taxes for the properties on the Judicial Sale list provided by Pike County Tax Administration on August 6, 2019.
ITEM ND. 5(B): Miscellaneous Correspondence	The Board reviewed various Miscellaneous Correspondence and had no comments.
ITEM ND. 6: Emergency services reports	Milford Fire Dept. reported 172 Fire and 403 EMS calls year-to-date.
	DTVFD President Joe DeMaio reported that here were 3D fire and 124 EMS calls in July. They are starting numerous repairs to the firehouse, and will be refurbishing the ladder truck soon.
ITEM ND. 7: Roadmaster Report	MDTION was made by Ed Nikles, seconded by Dennis Brink, and unanimously carried to approve the July 29-August 11, 2019 Roadmaster Report as submitted.
